Apologies were received from 9 members and these are noted on the attendance book.

Minute of the 117<sup>th</sup> Annual General Meeting 8<sup>th</sup> May 2014. This had been distributed and was available on the web site.

The adoption of this being a true record of the meeting was proposed by Colin Martin, seconded by Peter Bowyer, and duly signed by Chairman Neil McLain.

Matters Arising. Jim Cullen informed the meeting that the RCCC committee set up to look at the role of Areas and Provinces in the structure of the Royal Club had completed its review and its report had been approved by the RCCC Board. The recommendations made are to be put to the RCCC AGM on 18 June 2016 for approval. The draws were also made for the Melrose Kettle, Dun Trophy and Harry Hogg. The draw for the Border Gala Cup will be made later once all the entries are confirmed as there is discussions to take place regarding the rules later in this meeting.

Waldie Griffiths. It was decided that the committee would consult with the Secretary as to the order of precedence in the BIR competitions to decide who would be the skips and who the reserves for this competition.

# AOCB.

Gala Cup Rules – copies of the proposed changes had been circulated. After discussion the consensus was that a reserve would be allowed from another club. The extra wording added to rule 43 is in *Italics* below 43. The competition shall be open to team(s) of any two men and two ladies, playing in any order, who are members of the same Club as defined in rules 24 and 25. Should a club be unable to get two ladies from their own club a lady from another club may play at lead.

The above change necessitates extra wording to be added to rule 25 and is also noted below in *Italics*. **25.** Rinks shall consist of all regular members of Clubs in the Border Province wherever resident, and or Occasional Members of such clubs resident in the Border Province only *unless the individual competition rules state otherwise*.

**Sponsorship of stones in memory of Robert Forsyth** - The proposal to sponsor two stones (a 5 and a 6) in memory of Robert was made by President John Hodge and unanimously seconded.
